Optimal Use of Road, Traffic and Travel Data

- 1. EU-wide real-time travel information
- 2. Collection and provision of road data
- 3. Accurate public data for digital maps
- 4. Free minimum traffic information services
- 5. Promotion of multi-modal journey planners




Action 1.1 EU-wide Real-Time Traffic and Travel Information Services

- Dynamic market development; increasing demand for European and multi-modal services
- Objectives
 - Fair and transparent access to public data
 - Promote public-private co-operation
 - Increase data quality
 - » Improve multi-modal co-operation
 - » Encourage (cross-border) data exchange
- Results of a first study (to be published in April)
 - » proposal for a European framework for a regulated market for traffic and transport data
 - roles, data access, data exchange, licences



Action 1.3 Accurate Public Data for Digital Maps

- Availability of accurate public data for digital maps and their timely updating
 - common minimum requirements
 - » procedures for fair, simple and transparent access of map providers
 - minimum requirements for updating
 - » standardisation needs
- Taking into account results of eSafety Digital Maps Working Group and ROSATTE project
- Ongoing study on state-of-the-art and future requirements
 - workshops in Brussels: 29 March and 21 June (tbc)



Action 1.4 Free Traffic Safety Information Services

- Specifications for data and procedures
 - Free safety-related traffic services for all travellers
 - Harmonisation of a Europe-wide minimum service free of charge to the user
 - Establishment of suitable organisational models
- Results of a first study (to be published in April)
 - free traffic safety information service generally desirable but different stages of readiness
 - first definition of safety related road incidents
 - » broadcast via RDS-TMC and DATEX II feed to service providers
 - central coordination and registry



Action 1.5 Multi-modal Journey Planners

- Support of development of national, multi-modal travel planner and their EU-wide interconnection
- Status quo
 - at least 13 MS with national door-to-door service
 - y good examples at regional and local level
- EU-wide solution on the basis of distributed systems, need for interfaces
- Ongoing study (01-09/11)
 - assessment of technical possibilities and existing standards
 - consultation of stakeholders (web in April/May, Workshop 20 June 2011 in Brussels)
 - » preparation of specifications
- latest projects in FP7: iTravel, WISEMODE and new proposals



 - A. Identify and exchange **best practice** for the key applications of urban ITS
 - B. Elaborate **guidelines** for the key applications (specific regard to interoperability and continuity)

C. Identify the need for further standardisation


Urban ITS Expert Group - Status

 teams per topic
- Associations, ITS Committee and Advisory Group in the information loop
- Main deliverables
 - Best practise in urban ITS (interim) Nov 2011
 - Report on standardisation needs Apr 2012
 - » Best practise in urban ITS Jul 2012
 - Suidelines for the key applications Nov 2012
- Meetings
 - » 08/12/10, 09/03/11, Jun 2011 (tbc), Nov 2011
 - 2012: Feb, Jun and Oct



Further Topics with an Urban Connection

- Continuity of traffic management (study 01-09/11)
 - interconnection of traffic management centres, including continuity of strategies across the interurban/urban interface
- Vulnerable road users (study 01-05/11)
 - impact of ITS on safety and comfort of vulnerable road users
- ITS knowledge toolkit (2 DECIDE)
 - beta version for testing in April
 - » final version in Oct 2011



Further Topics with an Urban Connection

- Guidelines for public funding of ITS (study 12/10-05/11)
- ITS framework architecture
 - inclusion of urban level into FRAME, eFRAME??
- Data protection
 - revision of the general EU legal framework: legislative proposal in 2011
 - study on ITS issues foreseen end of 2011




Intelligentes, interoperables Ticketing

ITS Directive (2010/40/EU)


Directive 2010/40/EU in force since 26 Aug 2010

Framework for the Coordinated and Effective Deployment and Use of Intelligent Transport Systems

- Road transport and interfaces with other modes
- Safer, more coordinated and smarter use of transport networks

Objectives


- Establishing a framework for coordinated and effective deployment and use of ITS
- Setting common priorities
- <u>Development of specifications</u> and standards






ITS Directive: Priorities and Timing

- until end of 2012
 - » Harmonised, interoperable EU-wide eCall
 - » Road safety related minimum universal traffic information free of charge to users
 - Information services for truck parking
- until end of 2013
 - » EU-wide real-time traffic information services
 - » Reservation services for truck parking
- until end of 2014
 - » EU-wide multimodal travel information services



ITS Directive: Specifications

- Functional, technical, organisational, service provision specifications
- Procedure
 - » delegated acts (Art. 290 TFEU)
 - » based on standards (where appropriate)
 - impact assessment prior to adoption
- Obligations for Member States
 - ensure use of specifications when ITS is deployed
 - cooperate in respect to priority areas
 - deployment obligation only after adoption of co-decision proposal




